Age: 39

Public Information:

Alex Weingarten is a prominent attorney known for his work in the field of entertainment and business law. He built a successful legal career, establishing himself as a go-to lawyer for clients in complex legal matters. As Jamie Spears's lawyer in the highly publicized legal battle over Britney Spears's conservatorship, Weingarten has been thrust into the spotlight, facing intense scrutiny and media attention. Name: Andrew Wallet

In 2008, Andrew Wallet was appointed by Britney Spears's father, Jamie Spears, as co-conservator, effectively controlling all of Britney's finances. He acted as an estate manager, overseeing 15 separate entities, and helping to keep those Britney worked with from derailing her rehabilitation efforts. In January 2019, Britney Spears announced her "indefinite work hiatus." Shortly after, Wallet resigned from his position. While he was working as Britney's estate manager, he was paid a compensation of \$426,000 a year, a significant sum of which he came under fire for receiving by #FreeBritney supporters.





Name: Bryan Spears

Age: 46

Public Information:

Bryan Spears, is an American film and television producer. He is the older brother of Britney Spears. When he was 22, he moved to New York City to start his career. After Britney became famous, Bryan began working as a manager for the Spears family. Before his father was granted conservatorship over Britney, Bryan was paid \$200,000 for “services rendered.” In later interviews, Bryan described the conservatorship as “a great thing” for the Spears family. He supported his father’s decision, claiming it was the best outcome of a difficult situation. He brings a new perspective to this discussion, claiming that the family sacrificed so much to keep Britney’s career going they deserved something in return. He does, however, acknowledge knowing that Britney had wanted to get out of the conservatorship.



Name: Christina Aguilera

Age: 40

Public Information:

Christina Aguilera and Britney Spears have had a long relationship full of ups and downs. From growing up together and both growing up casted on *The Mickey Mouse Club*, the media has often pitted them against each other as rivals. Christina Aguilera, who has accumulated 5 Grammy Awards, 2 Latin Grammy Awards, 1 Guinness World Record title, recalls on how “[she] remember[s] being hurt by commercials on MTV, pitting Britney as the good girl and me as the bad girl.” Yet this competitive atmosphere didn’t stop Aguilera from voicing support for Spears saying that “It is unacceptable that any woman, or human, wanting to be in control of their own destiny might not be allowed to live life as they wish.”





Name: Felicia Culotta

Age: 55

Public Information:

Felicia Culotta has known Britney since Britney was five years old. Culotta began working as Spears's assistant in 1997. During her time with Spears, she appeared as a school teacher in the iconic “..Baby One More Time” music video. Along with working as Spears's assistant, Felicia and Britney became close friends. Felicia stopped working for Britney in 2007, and this was around the time when Britney experienced her mental breakdown. Following this, Culotta went on to work with the Jonas Brothers. Since then, Culotta has been in little contact with Spears.



Name: Jamie Lynn Spears

Age: 29

Public Information:

Jamie Lynn Spears, Britney's younger sister, is an actress and musician, most famous for her role as Zoey Brooks in the early 2000s Nickelodeon show, *Zoey 101*. As a child, Spears traveled on tour with her sister and described her home life as unstable, but loving after her parents' divorce. Spears starred in *Zoey 101* for four years until the popular series' finale in 2008. After a hiatus from the entertainment industry, Spears joined her sister in the music industry with her country EP. Currently, Jamie is planning on releasing a memoir on her family and life story. Britney has accused Jamie Lynn via social media of participating in her conservatorship and not attempting to stop it. Jamie has denied all allegations and claims that she did not know the details of Britney's abuse.





Name: Jason Rubin

Age: Delegate's discretion

Public Information:

Jason Rubin, a LinkedIn connoisseur and forensic accountant with a specialty in “securities litigation, criminal, real estate, intellectual property, bankruptcy, fiduciary, and family law”, is Britney’s leading choice for a replacement conservator. Based on his work with other familial feuds, Rubin and Britnet are positive that he can handle the conservatorship and achieve a healthy compromise for the Spears family. Rubin plans to supervise and facilitate the house and financial assets heavily due to his expertise in accounting.



Name: Jason Trawick

Age: 50

Public Information:

Jason Trawick is a former talent agent and entertainment executive known for his relationship with Britney Spears. He began his career at William Morris Endeavor Entertainment before becoming engaged to Spears in December 2011, though the engagement ended a year later. Despite their romantic split, Trawick maintained a professional relationship with Spears and remained supportive during challenging times, including her conservatorship. While his role in Spears's legal affairs remains private, Trawick's connection to the pop star remains of interest to fans and observers.





Name: Jeffrey Wexler

Age: Delegate's discretion

Public Information:

Jeffrey Wexler is an attorney for Jamie Spears, Britney Spears's father. Jeffery has been on Jamie's legal team for 16 years, representing the conservatorship since its start in 2008. One prominent case that Wexler has worked with the Spears family was against Jon Eardley. Jon, a concerned fan, sued the Spears family in 2008 over an unfair split of assets when the conservatorship was hashed out. Wexler played a pivotal role in proving the intentions of the conservatorship and successfully took more power from Britney.



Name: Jodi Montgomery

Age: 59

Public Information:

Jodi Montgomery is a three-year member of Britney's care team and a conservator, or a court-mandated individual who handles the financial and personal of a conservatee. With a bachelor's degree in social welfare, from the University of California Berkeley, and her own fiduciary, Pais Montgomery Fiduciary, Montgomery prides herself in being a master of her craft. As of March, Montgomery has set clear intentions that she would like to precede Jamie Spears's conservatorship of Britney. Furthermore, she spends time advocating for causes that she cares about, working with AIDS Centers in Pasadena and the Special Olympics.





Name: Justin Timberlake

Age: 41

Public Information:

Justin Timberlake and Britney Spears dated for three years before parting ways in 2002. In early 2021 amid the drama related to the Britney Spears case, Timberlake released an apology addressing how he benefited from condoning a misogynistic system and objectifying women in the entertainment industry. While he didn't directly mention the conservatorship case, his apology addressed the broader issues of media scrutiny and treatment of women in the public eye.



Name: Kevin Federline

Age: 43

Public Information:

In his early career days, Federline worked as a backup dancer for stars like Michael Jackson, Justin Timberlake, Destiny's Child, Pink, and most notably, Britney Spears in 2004. He became famous through his association with Spears. The two eventually married in 2004 and had two sons together, but the pair divorced in 2007. Following their relationship's end, the two went through a publicized child custody battle. Federline eventually gained and retained sole physical custody of the boys. The media often characterizes Federline as a "gold digger" because of his relationship with Spears.





Name: Larry Rudolph

Age: 57

Public Information:

Larry Rudolph is a prominent music industry executive and talent manager best known for his long standing professional relationship with Britney Spears. He first met Spears in the late 1990s and played a pivotal role in launching her music career, serving as her manager during her rise to superstardom. Rudolph's expertise and strategic guidance were instrumental in shaping Spears's image and navigating her through highs and lows, both career wise, and personally. Working so closely with Spears he has seen the hardest parts of her life, and he finds great importance in making use of his biggest career break, staying on top. However, he is facing criticism and scrutiny from fans and the media during periods of turmoil in Spears's personal life, including her highly publicized struggles with mental health and her conservatorship battle. In addition to his work with Spears, Rudolph has represented numerous other high-profile artists and celebrities, further solidifying his reputation as one of the music industry's most respected talent managers.



Name: Lisa MacCarley

Age: 58

Public Information:

Attorney Lisa MacCarley has represented Britney Spears in legal proceedings, specifically in relation to the abusive conservatorship imposed on her. This conservatorship refers to the legal arrangement where the court appointed Jamie Spears, Britney's father, as her "conservator," to manage her affairs. This, as described by Attorney MacCarley is "unconstitutional. [The conservatorship] violated the very basic notion of her constitutional rights. They did everything wrong." As a major supporter of Britney, the fight will continue until justice is served.





Name: Lou M. Taylor

Lou M. Taylor is the founder of Tri Star Sports & Entertainment Group, a firm specializing in financial and business management for celebrities like Britney Spears. Serving as Spears's former business manager, Taylor guided her financial affairs during her rise to fame but faced scrutiny during Spears's conservatorship battle. Questions about Taylor's control over Spears's finances and allegations of mismanagement have sparked legal scrutiny. Despite controversies, Taylor remains active in the entertainment industry, managing finances for various clients and aiming to preserve her reputation.



Name: Lynne Spears

Age: 66

Public Information:

Lynne Spears is the mother of Britney Spears, her younger sister Jamie Lynn Spears, and her older brother Bryan Spears. Before becoming a celebrity mom, Lynne worked as a school teacher. Lynne and her husband Jamie, the children's father, divorced in 2002 after being married since 1976. The divorce was hard for Lynne and the kids. Lynne got involved in Britney's conservatorship battle in 2020 when she asked to be involved in the financial decisions on Britney's behalf. But this request was rejected by the court. Recently, Britney alleged that Lynne was involved in planning the conservatorship and accused Lynne of pretending not to know that the singer would be placed in a conservatorship in 2008.





Name: Madonna

Age: 63

Public Information:

Madonna is a pop legend who gained stardom in 1983 when she released her first album, self-titled *Madonna*. Madonna would go on to dominate the music industry in the '80s and beyond with top hits like "Holiday," "Like a Virgin," and "Material Girl." Madonna and Britney met in 2001 at one of Madonna's concerts. Later that year, the pair would collaborate on the song "Me Against the Music" on Spears's *In the Zone* album. Madonna is not only a friend of Spears but also a significant supporter of Spears's freedom. She has advocated on social media, posting messages on her Instagram story writing, "Give this woman her life back." Madonna is willing and eager to help her friend in any way she can.



Name: Mathew Rosengart

Age: 58

Public Information:

Matthew Rosengart, a former federal prosecutor and Trial Attorney for the United States Department of Justice, is renowned for his aggressive advocacy in high-stakes legal proceedings. He's become sought after by high-profile clients, especially in Hollywood. His decision to represent Britney Spears marked a crucial moment in her fight to end her conservatorship, leveraging his strategic acumen and extensive experience. Rosengart's connections within the industry further enhance his ability to advocate for Spears's rights and autonomy, drawing support from influential figures.





Name: Paris Hilton

Age: 41

Public Information:

Paris Hilton is a longtime friend of Britney Spears and was previously known for being the great granddaughter of the founder of Hilton Hotels. However, she established herself beyond her family's fame when she became globally famous for her fashion modeling in the 2000s, and her appearance in the reality TV show, *The Simple Life* (2003 - 2007). As one of Britney's closest friends who's known her for years, the two practically "created" the selfie, and routinely hang out. Hilton, a big supporter of Spears, commented on the ongoing situation explaining how "after just working your whole life and working so hard, [Britney is] this icon and I just feel like she has no control of her life whatsoever and I just don't think that's fair." Hilton is dedicated to helping Spears.



Name: Robin Greenhill

Age: 59

Public Information:

Robin Greenhill is the Services Director at TriStar Sports and Entertainment. TriStar is suspected to have been involved in the creation of the conservatorship, but they have denied all allegations despite having been paid exorbitant amounts due to the Conservatorship. Robin specifically was accused of helping Britney's father spy on Britney. Recently, Robin has hired a lawyer to protect her from charges relating to her involvement in unpermitted divulgence of private information. It is in Robin's best interest to keep Britney under the Conservatorship but to deny all allegations of involvement putting or keeping her there.



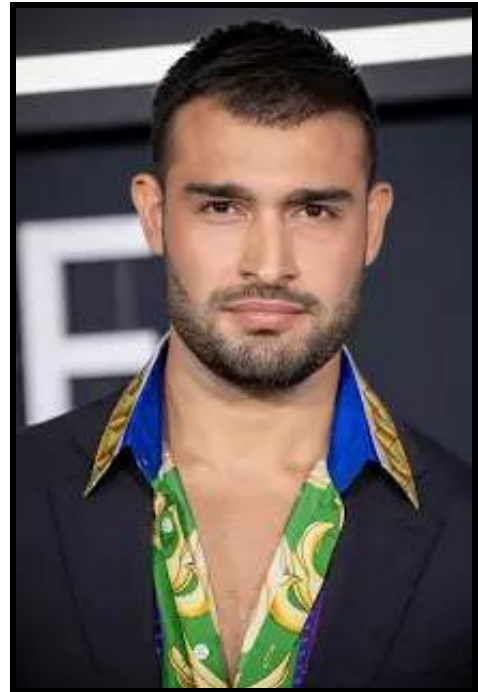


Name: Sam Asghari

Age: 27

Public Information:

Sam Asghari, Britney’s boyfriend since 2017, is an Iranian American model, actor, and fitness trainer. The two met on the set of her “Slumber Party” music video in 2016 and have been seriously dating since 2017. Despite dating for years, a source for *Forbes* confirmed that Britney was not allowed to marry Asghari without legal approval from her father. A former model and actor (appearing in *Black Monday*, *The Family Business* and *Hot Seat*), Sam is currently the owner of Asghari Fitness—a personal training website. Earlier this year, Sam stated that he has “zero respect for someone trying to control our relationship [his relationship with Britney] and constantly throwing obstacles in our way.”



Name: Sam Lutfi

Age: 47

Public Information:

Sam Lutfi has a tumultuous relationship with Britney Spears. He was Britney’s ex-manager and friend. However, in 2007 he was accused of being a bad influence on the singer and several restraining orders were issued against him. Spears’s family have been critical of Lutfi, claiming that he tried to control Britney for personal gain and exploited her during a time of personal and professional challenge. However, he denies all of these claims and has engaged in several defamation suits against the Spears’s family. Many other harassment rumors and allegations have surrounded Lutfi and his relationship with the Spears’s family.



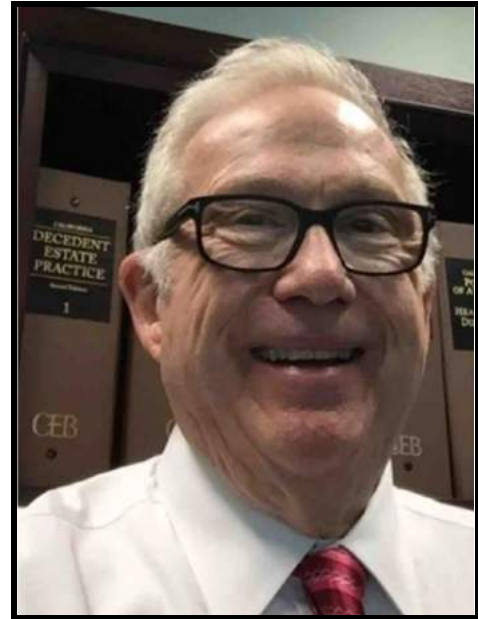


Name: Samuel Ingham III

Age: 70

Public Information:

Samuel D. Ingham III is a prominent Los Angeles-based attorney who gained significant attention for his involvement in Britney Spears's conservatorship case. Ingham was appointed to Spears's case by Judge Reva G. Goetz in 2008, although Spears had tried to retain noted trial attorney Adam Streisand to contest her father being made her conservator. With a background in law and extensive experience in representing clients in complex legal matters, Ingham played a crucial role in advocating for Spears's rights and autonomy within the confines of the conservatorship framework. He was responsible for articulating Spears's wishes and concerns to the court and negotiating on her behalf with other parties involved in the case. Throughout his tenure as Spears's attorney, Ingham faced scrutiny and criticism from Spears's supporters and advocates who questioned the effectiveness of his representation and the extent to which he truly represented Spears's best interests. Some critics argued that Ingham failed to adequately challenge the conservatorship or pursue alternative legal avenues to address Spears's grievances.
